Supervisor Stewart called the Public Hearing to order with the Pledge of Allegiance.

# Public Hearing - Establishment of Ambulance District

The Town Clerk read the Legal Notice then Supervisor Stewart opened up the hearing for public comments.

*Bruce Burditt* asked how much does the Town of Malone pay each year to the Fire District. Supervisor Stewart responded that the agreement was for approximately \$464,000.00.

Pat Sherwin asked when and why did the Fire and Rescue Departments separate. John Bashaw from Malone EMS responded that the department split in 2001. The reason for the split was that they were unable to find enough volunteers and needed to hire staff. Mr. Sherwin then asked if grants were available to help fund some of their needs. The response was that there are not a lot of grants available for EMS districts, if they could get one it would be a single use grant, they need consistent funding to support a building, staffing and equipment replacement as necessary. Mr. Sherwin also asked if they were paid for their services. Mr. Bashaw responded that they are paid for some services but not all. Mr. Sherwin also had a concern that this would compete with a local private business and that there is a lot of people living off of a fixed income, to add more to the tax bill will be a hardship. He also stated that he thought Alice Hyde Medical Center was going to be adding to their transport department and would reduce the number of transports needed from the Malone EMS. They said transport and 911 are two different areas and one would not affect the other.

George Rockhill asked if the town agrees to this Ambulance District will the town be buying the ambulances. It was stated that no, the district is set by Village and Town and they contract with an agency, that agency is responsible for all aspects of their operation.

Pat Sherwin said after listening and learning more about it he is in favor of the Town of Malone Ambulance District being formed.

Supervisor Stewart closed the hearing at 6:25 p.m.

Airport Lighting & Signage Grant Update: The FAA grant total is \$703,884.00, as Additive 1 was not funded by the FAA, only the base bid amount. This grant has been fully executed and submitted. Supervisor Stewart requested permission to sign the contract with Baseline King Corp. as the contractor for the project. They were the lowest bidder.

They reviewed the parameters of bid, the work schedule and logistics. Baseline King will be starting work on Monday, August 22, 2022 and estimates this project to take a month.

Ambulance District: Proposal as it pertains to the Public Hearing held earlier.

The board members thanked the Malone EMS and Northern Ambulance for the service they provide to our community. They feel strongly that this Ambulance District is needed in our community, for safety and growth.

# RESOLUTION OF THE TOWN OF MALONE TOWN BOARD

Whereas the Town of Malone, Franklin County, is desirous of providing and/or arranging for ambulance services to its residents and the Town desires that such service have sufficiently trained and skilled emergency medical technicians serving on its ambulances available to serve persons situated in the Town;

Whereas the town has prepared a map, plan and report that is in such detail as is acceptable to the Malone town board; and

Whereas the map, plan and report have been filed in the office of the town clerk pursuant to Section 209-c of the Town Law in advance of the adoption of this resolution; and

Whereas the town board has adopted an order and entered the same in the minutes of its proceedings reciting a description of the boundaries of the proposed ambulance district sufficient to identify the lands included therein as in a deed of conveyance, the improvements proposed, the maximum estimated amount proposed to be expended annually for the improvement, and the cost of the district to the typical property, and the fact that a map, plan and report describing the same are on file in the town clerk's office for public inspection and specifying the time when and place where said board will meet and hold a public hearing to hear all persons interested in the subject thereof, concerning the same; and

Whereas a copy of such order has been published at least once in the official paper of the Town of Malone, the first publication thereof which was not less than ten (10) nor more than twenty (20) days before the date set therein for the hearing had preceding this resolution; and

Whereas a copy of the order was posted on the sign-board of the town maintained pursuant to subdivision six of section thirty of this chapter, not less than ten (10) nor more than twenty (20) days before the day designated for the hearing since had on this issue; and

Whereas a public hearing was held on the 17th day of August, 2022 at 7 pm at the at the Town's offices with a street address of: 27 Airport Road, Malone, NY 12953, and

Whereas the board has determined that the notice of hearing was published and posted as required by law, and is otherwise sufficient; and

Whereas the board has determined that all of the property and property owners within the proposed district are benefited by the proposed district; and

Whereas the board has determined that all of the property and property owners benefited are included within the limits of the proposed district; and

Whereas the board has determined that the establishment of an ambulance district. A description is as follows:

All of that portion of the Town of Malone, Franklin County, New York which lies outside of the Village of Malone.

It is hereby resolved that subject to permissive referendum, that the Town of Malone establish an ambulance district for the benefit of all of the property and property owners in the proposed ambulance district; and

It is further resolved that such ambulance district shall include all of that portion of the Town of Malone, Franklin County, New York, which lies outside of the Village of Malone. It is anticipated that the Village of Malone will agree to extend the ambulance district into the village, so as to include the limits of the entire town.

It is further resolved that such ambulance district shall become effective immediately after approval of the voters or thereafter as may be required by law or in case no petition is successfully filed, after the time to petition for a referendum has expired.

It is hereby ordered that, the clerk of the Town of Malone shall file this resolution in the office of the Clerk of the Town and make such resolution available for public inspection.

It is further ordered that, the clerk of the Town of Malone shall cause to be prepared and have available for distribution proper forms for a petition seeking a public referendum and shall distribute a supply to any person requesting the same.

It is further ordered that, if, after the expiration of the time for filing a petition requesting that the matter be submitted to a referendum of the property owners of the proposed ambulance district, no such petition has been filed with the town clerk, the town clerk is directed to file a certificate stating such fact in the office of the county clerk;

It is further ordered that, upon the filing of such a certificate in the office of the Franklin County Clerk, the Board shall adopt a final order establishing the ambulance district.

This resolution has received the affirmative vote of at least a majority of the Board of the Town of Malone, Franklin County, as signed below and such resolution is hereby approved.

Councilor Johnston: Work continues on the ball field. The infield clay and sod are done, new fences should be up by mid-September. With the funding from Assemblyman Jones, next year they would like to put up a building for storage, locker rooms, a possible concession stand, a ticket booth and restrooms.

Councilor Taylor: The electrical project at the Pavilion is complete.

- -Installed drainage for the Pavilion which will help for the Fly In and Farmers Market.
- -Met with Airport Manager Burditt in preparation for the Fly In. Together they created a list of projects that need to be done.
- -Paved the parking lot at the Town Offices.
- -The highway crew will be going back to road maintenance, cleaning up ditches, hot patching, etc.

Councilor Walbridge congratulated Superintendent Andrews, Deputy Superintendent Manley and the highway crew for a job well done.

## AIRPORT MANAGER:

Airport Manager Burditt updated the Board on the upcoming Malone Fly In. Buses have been parked up front by the road for the sponsor advertisements. Boy Scout Troop 61 will be parking cars. There are 35 vendors signed up to participate. There will food trucks and a bar. Two bands will be performing on Saturday and one on Sunday. Transportation will be provided again this year to go the Wilder Farm. A Paraglider and Lifenet plane will be there on Saturday. On Sunday, if available there will be a Lifenet helicopter, if not the plane will be back. State police will be in attendance with drones on both days. There will be two planes and one helicopter doing rides.
