Councilor Scharf further indicated that she and Josey Delaney would be representing Malone at a New York State DASH Conference representing regarding the Complete Streets project and will be coordinating help with policies. The reason they were asked to present was there had was so much support for Complete Streets with Village, Town and School System. They believe we are working with the health of our community and our government is supporting those efforts.

Councilor Scharf further discussed the Notice from New York State Maisonnette about using Airport as a weather station. Councilor Scharf's issue was if the community could use this service it would be good, but wanted to know if it would serve the pilots, but did not want it to hurt chances of obtaining grant for weather station from the FAA. If we allow them to do it, it obviously will help our community, but we want to help the pilots and airport, but do not want to interfere with our chances for better weather stations. New York State indicated it would not affect our chances for the grant which we are in line to receive. Mark Besio indicated it is to be absolutely free. Supervisor Maneely indicated it would provide accurate weather for Malone. Bruce Burditt asked if there was any indication where it would be put. At this time there was no location noted. Supervisor Maneely will contact Mary Kay Gunther at Passero.

SUPERINTENDENT OF HIGHWAY REPORTS:

Superintendent of Highways Bruce Mallette states the department is taking care of the water from the recent snow melting. He further indicated he was in Albany on March 4th with New York State Superintendents and that there is \$500 Million up for grabs. There was between 1,000 and 1,200 Superintendents there. The Superintendents spoke with Representatives Duprey and Little about concerns. CHIPS money has not gone up in 10 years, and they want to spend this money elsewhere. If we received all, it would go up 68%; chances of receiving are pretty slim. Smaller towns rely on CHIPS to get things done.

Superintendent Mallette also reported on meeting with DEC on soil erosion. There is a whole new process for road construction. There will be forms to be filed within five days. If opened up, land will need to be seeded within 14 days of being opened up. Soil and Water has a hydro seeder. Somewhere down the line we may need to purchase a hydro seeder. We can look into that when the times comes.

Superintendent Mallette also reported that the department has been cutting ice off roads and using the grater peeling off ice. We had one thaw this winter. Getting things back to normal.

Superintendent Mallette also reported six highway employees, including him, attended training at soil and water. Anyone that has part in digging, there will always be one employee with this training on-site.
