Dog Census -

This fee is charged, in addition to the regular license fees, for dogs unlicensed or overdue for renewal, at the time of the enumeration (dog census). An advertised amnesty period, prior to commencement of the enumeration, would be provided for those delinquent dog owners who would like to avoid the extra fee. Those who are current would not be affected. The DCO reported that this tactic was successful in the Town of Burke, reducing the number of court summons issued. The Supervisor thanked the DCO for her presentation.

# Justice Court 2012 -

**Town Justice Michael Lamitie** addressed the Board with a report of Malone Town Court activities, noting that the Malone Court is the most active in Franklin and St. Lawrence Counties. He provided an informational hand-out with 2012 statistical and financial court data. Justice Lamitie also reported on the court renovations, which are nearing completion. A second grant has been awarded for the purchase of furniture. Justice Lamitie presented a letter of resignation from Court Clerk Amanda Drake.
