Public Hearing:

At 5:30 pm, with notice provided and read aloud, Supervisor Maneely opened the Public Hearing on Local Law#3-2013, entitled: "To Override the Tax Levy Limit Established in General Municipal Law 3-c" Town Clerk Hafter read the proposed law aloud.

Councilor Scharf noted that the Town has suffered considerable and costly storm related damages in the past year.

Deputy Supervisor Walbridge said a tax certiorari case successfully brought by U.S. Border Patrol added to the Town's financial burden, and other cases are pending.

Don Hardy, a Malone resident, asked whether the Town receives any monies from the Mohawk Casino. **Supervisor Maneely** answered that the Town receives neither Casino nor sales tax money from the county.

Budget Office Stewart explained how the state determines the levy limit for the towns, and why she recommends the Town Board consider the override. She said the tentative budget, which includes all contractual obligations, business costs and requests from department heads and employees, exceeded the limit to begin with by almost \$712,000. After three work sessions, the board was able to cut more than \$668,000. More may be cut, but the total is not likely to come under the limit. Since the state penalizes towns that go over the limit without benefit of a local law, it is safest to have it in place.

At 6:00 pm, with no further comments from the Board or public, Supervisor Maneely closed the the public hearing.

Local Law #3 -2013
A local law to override the tax levy limit established in General Municipal Law 3-c

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Malone, County of Franklin pursuant to General Municipal Law §3-c, and to allow the Town of Malone, County of Franklin to adopt a town budget for (a) town purposes (b) fire protection districts and (c) any other special or improvement district governed by the town board for the fiscal year 2014 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Malone, County of Franklin is hereby authorized to adopt a budget for the fiscal year 2012 that requires a real property tax levy in excess of the limit specified in General Municipal Law §3-c.

Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.
