Junk Storage Law

Attorney Anderson-Duffy and Code Officer Crossman met to discuss modification to the Junk Law. The definition of Junk was expanded to include three different sections, one is a section which was revised to show one junk vehicle, or one piece of junk equipment, etc.. We added language using the definition from the Property Maintenance Code from New York State and expanded to include the definition of rubbish. We also added the definition of junk from the Property Maintenance Code. This will give Code Officer Crossman broad authority to regulate people who do not take care of the exterior of their property. With regard to keeping of junk, Code Officer Crossman thought it would be best to keep this section the way it is. If someone has a large farm and they have junk in the middle of their property that is not visible, it is okay. We just want to regulate the visible junk.

BOARD MEMBER/COMMITTEE ITEMS:

Councilor Sullivan wanted to thank Paul Walbridge for his 12 years of service to the Town of Malone and wishes him luck in the future. We have been on the same committees and worked together a lot. We made a pretty good team.

Deputy Supervisor Walbridge thanked everyone stating he "had a good run". I think Malone has really come forward, looking back over the years, I am a taxpayer who has some wishes, wants and direction. Remember where you come from and take Malone forward. He wishes for new board member Ed Lockwood to take Malone forward an noted he probably is the best to take over for me. I got on the Board having a shine for youth and shine for elderly. He further stated that \$5,500 is not enough for the job the Board does. The Board deserves more money. I know no one is in it for the money. Wishes everyone the best of luck. I came in with no agenda and leave with no agenda. Love to all. Thank you. Supervisor Maneely thanked Paul for the job he has done.

Councilor Sullivan stated he is concerned over Indian Trails controversy and I think everyone lost, no one came out ahead, but I hope that individuals will not hold a grudge and we have to work with the Village. We need to forge ahead and forget what happened over Indian Trails. Councilor Taylor stated sometimes individuals say things they do not mean, we work with the Village and they work with us. The Village and the Town have to work together.

Supervisor Maneely stated we talked to the Mayor about a Trustee and they are speaking as comments were very inappropriate.

Councilor Scharf stated Complete Streets had a meeting with Jerry in the Village regarding the sidewalk on Webster Street and they will be scheduling a meeting to discuss the cost and plan.

The entities are intertwined and need to cooperate. Councilor Scharf stated proof that we try is the article about us not giving money to the rec park. Specifically when we had our budget meeting, I asked Andrea if we would have enough money to contribute. The dredging is important and we wanted it to come through. Not sure where information in newspaper article came from, but it was explained about the 40% split. There is no reason for this. Deputy Supervisor Walbridge stated it would be a good way for Ed Lockwood to take charge -- to be on the Rec Committee. It works hand in hand with Malone Minor Hockey. Councilor Scharf reiterated we are extremely supportive of the Rec Park. It was discussed at budget time to be sure there was money there, and that was in October.

Councilor Sullivan indicated there have been several mass mailings about clean energy and he advises constituents to look closely at the flyers and do their homework on clean energy.

Councilor Scharf stated there will be a meeting on the sidewalk for Complete Streets. Right now we are applying for a grant in combination with safe routes to school. Complete Streets has three projects we are working towards in 2016 – Jayne Street, Webster Street and State Street. Councilor Scharf stated Jerry from the Village is super helpful. Supervisor Maneely realizes more and more how bad we need sidewalks on State Street. Councilor Scharf indicated when Complete Streets did forum a few weeks ago, Wayne Miller had gone in the middle of the day and taken a picture from the rec park entrance looking down State Street, there were two children in the middle of the road, a senior citizen with a dog, and buses in two directions and cars parked on the side. I had never seen it quite so congested, but it was pretty scary. It is a busy place, and residents want their children to be able to walk to the rec park and arena, and they want them safe.

Deputy Supervisor Walbridge stated he is most proud of the Board always coming to a consensus and discussing everything until we couldn't discuss it anymore, and sticking together. That is one thing, Ed, you are going to like about this Board, and you don't have to be afraid to voice your opinion or concerns. People listen, we hash it out and come to a consensus. I am very, very, very proud of this Board. I have never been a part of a Board that has been able to do that. I am going to miss everyone.

SUPERINTENDENT OF HIGHWAYS:

Highway Superintendent Mallette thanked Paul for his service and welcomed Ed Lockwood. He indicated the department has been catching up on little things and hauling sand. The new truck should be here by the end of the week.

Superintendent Mallette asked for approval to purchase a used truck. There is enough money in my budget for one, possibly two trucks. The truck discussed at last meeting was not a good option. He found a 2013 truck, newer than any other pick-up truck we have in garage, at Jay Sullivan's dealership with 150,000 miles, all highway, for \$19,900.00, which is a very good deal. It is a full mega cab. Superintendent Mallette will check into warranty. We have had a good year, so there is a lot of money to roll over. The garage had three trucks that are in pretty bad shape. Mr. Sullivan also has a 2008 with 58,000 miles for \$17,500, which is in good shape. Both trucks are good for the money. With the Board's approval, I would like to purchase one, or possibly two, to upgrade his fleet. Supervisor Maneely stated we started this at Budget time and turned you down and reminded you of a tax cap. He further reminded Superintendent Mallette that the department should be utilizing the bus, and he would approve purchase of one truck. Councilor Scharf stated they need to check on the warranty for the vehicle, and if we have the money, we should purchase a truck while we have the funds and not interfering with taxes, and there is money left over. Councilor Sullivan would approve the purchase of one as well. We are upgrading your fleet all the time. Last year you purchased a one ton and a snow plow, and this year a tractor trailer. Councilor Sullivan is in favor of one truck. Budget Officer Stewart stated it would be out of this year's Budget. Superintendent Mallette stated he would like to purchase the 2013 truck.
